VCCA Lower Michigan Region Board Meeting Sunday, September 16, 2018, at Sloan Museum

General Meeting called to order at 1:02 p.m. by Director Brian Granger. Other Board members present were Jim Schott, Pat Mehl, Bruce Granger, Phyllis Rickabus, Majorie Henige, Andy West, Richard Beach, Lloyd Henige, Andy Mehl, and Tim Reinke. Absent Mike McCarty. Minutes: of the June meeting as printed in the Chevy Chatter were accepted as published. Motion Presented by Pat Mehl of the LMR-VC-CA By-Laws Committee (also Brian Granger, Phyllis Rickabus): We move to present the Revised By-Laws to the membership of the Lower Michigan Region - VCCA for a vote of acceptance. Per our By-Laws, this vote is required to be: (1)A majority vote of all the Region members in good standing are those who have paid their dues and consist of those members of each household which are shown on record in the National VCCA membership database.

(2)Upon approval of this motion, by show of hands of the majority of members present at the meeting where the motion is presented, the By-Laws Committee will prepare and mail to each member a copy of the revised By-Laws document, and a numbered ballot, which will be a self-addressed, stamped postcard which can be returned when completed.

(3)A ballot which is not returned or is returned with either no selection or a "NO" selection, is considered a NO vote.

(4)Upon the conclusion of the vote (date of return of ballots to be determined, but not later than December 31, 2018), the Committee will review and count all ballots. If the number of YES votes exceeds 50% of the total members in good standing, the Revision will be retained, and instituted immediately.

Motion was seconded by Phyllis Rickabus. Unanimous vote to accept the motion. Deadline to return ballots was determined to be October 31, 2018 (mailing deadline of Oct. 20, 2018).

Other business: Brian Granger has 2017 awards to still present; members were not present at the meeting.

The General Meeting was tabled to present the slate of candidates for 2019 Board positions:

Assistant Director: Andrew Mehl Treasurer: Pat Mehl (re-election) Jr. Board Member: Pam Mehl

Notes: This year's Junior Board Members will step up to Senior Board Members. Under current By-Laws, we are still looking for two more candidates to fill the Jr. Board member positions. Appointed positions: Phyllis Rickabus will return to her position as Membership Coordinator. Denise Thomas has volunteered to take the position of Sunshine Coordinator.

Additional nominations will be accepted at October 20, 2018, meeting. Elections will follow immediately follow.

Nominations meeting was closed.

Treasurer's Report: Pat Mehl reports that we are still maintaining a healthy bank balance. All budget items are within the planned amounts thus far this year. Our income will include the renewal of memberships in the next three months. **LMR Tours and Activities:**

(1)Mothball Tour Registrations are due by October 1, 2018. The Board of Directors will meet at noon during the Mothball Tour on Saturday, October 20. This is for the annual budget and schedule planning. The General meeting will begin at 1 p.m. with the main business to hold Elections for the 2019 year.

(2) The annual banquet will be held Saturday, November 3, at the Brick Street Grill, Grand Blanc, from noon to 4 p.m. Cost is \$40 per person. The buffet will include fried chicken, roast beef, mashed potatoes, tossed salad Californina mixed veggies, roll & butter, and apple pie for dessert. RSVPs are due by October 21. Membership: Phyllis reports that we have 100 active households, with a total of 157 paid members. She also encouraged us to buy name badges that the Indiana Region is selling as a temporary replacement for our VCCA name badges suppled when one becomes a member. National Board: Tim Mehl reported the schedule of upcoming Central Meets: 2019: Lafayette, IN hosted by Indiana Region; 2020: Cleveland, Ohio hosted by Cuyahoga Region; 2021: Mini meet in Dayton-Cincinnati area, hosted by MiamiValley Region, followed by Anniversary meet to be held in Bowling Green, KY; 2022: Michigan hosted by Lower Michigan Region. Newsletter: Barb Sparks gave no report. Sunshine: Marjorie Henige sent get well cards to Denice Thomas and Mary Granger; birthday greetings to Winnie Crawford on her 100th birthday; memorials in remembrance of Bud Cook, Don Gale and Yvonne Davenport; passings to be acknowledged to Norma Clark, Walt Fuelberth. Also long time member of National, Jack Macy, is terminally ill. Cards were suggested to his address: Jack & Pam Macy, 16961 Lakeville Crossing, Westfield, IN 466074-8179. Historian: Bruce Granger reported we have a complete series of G&D's going back to 1962, thanks to the collection donated by the Reinke family. He said that at one time there were five 1975 Chevy Club convertibles, now there are two. New **Items:** Robin Reinke recognized the service of Tim, Pat and now Andrew Mehl to the club. All three hold positions and Andrew volunteered to serve as the 2019 Assistant Director. Jim Schott "volunteered" to be representative for monthly meetings at Sloan Museum; Bob Sovis indicated the awards vendor he used has moved out of the area and he is looking for suggestions for other vendors. 50/50 winner was Andy West, who donated his winnings back to the club. There were a few badge fines paid.

Adjournment: Ole Hagen motioned for the meeting to end at 2:30 p.m.
