# Minutes of the October 15 Meeting

The meeting was called to order at 2:30 p.m., following a break from the Board of Directors' Meeting, by Director Bill Anderson. • **The Pledge of Allegiance was recited.** • No guests or new members present. A moment of silence was offered for Walt Arvoy, long-time LMR member who passed away in the last week. • **The September meeting minutes were approved, with changes, as was the September Treasurer's report.** • The General Membership Meeting was suspended in order to conduct Elections of Officers for 2018. After no new nominations from the attendees, the nominations were closed with a motion from Phyllis Rickabus, seconded by Bob Sovis. **By general acclamation, the nominated slate was elected: Director Brian Granger; Assistant Director Jim Schott; Secretary Mike McCarty; Treasurer Pat Mehl; Senior Board Members Tim Reinke, Bruce Granger, Andy West; Junior Board Members Richard Beach, Lloyd Henige, Andy Mehl.** • The General Membership Meeting was resumed, with discussion regarding proposed motions to amend the LMR's By-Laws. The proposed amendments, as presented by Andy Jurski, and Bill Anderson are: 1. Board members and officers serve minimum two-year terms. (*Revise Article II, Section 2*) 2. Eliminate 4 Members-at-large, with the remaining 2 to be appointed, not elected. (*Revise Article II, Section 1*) 3. Remove term limits for each elected position. (*Revise Article III, Section 1*) 4. Change the dates for Officer Nominations from October to September, with additional nominations entertained in October just prior to elections. (*Revise Article IV, Section 1*) • Discussion included pros and cons of each motion, and a general discussion to review the language in the by-laws due to some confusing terminology. It was determined that a committee will be formed (Brian Granger, Pat Mehl, and Phyllis Rickabus) to further research the proposed changes and present the amendments at a meeting in 2018, to be determined. • **New Business:** Treasurer's Report by Pat Mehl: We are on track to finish the year within budget, and the 2018 Budget was presented. • The remaining activities for 2017 were

reviewed. The Mothball Tour has 11 parties registered. The banquet currently has 30 reservations; deadline for reservations is October 24. • **Membership Update by Phyllis Rickabus.** We currently have 115 members, 27 of which were in arrears for 2017. Phyllis had Jr. Board members contact those in arrears; 3 of those have renewed their memberships thus far. Folks have until January 1, 2018, to renew their 2017 memberships. Membership renewals for 2018 are now being accepted and are due by January 1, 2018. Anyone not paid up by May 1 will have their membership cancelled, after appropriate notification. • **Newsletter Update by Barb Sparks:** Nothing to report. Requested photos from the upcoming Mothball Tour. • **VCCA National Director Update by Tim Mehl:** Tim reports that the 2018 Central Meet will be in Peterborough, Ontario, and the 2019 Central Meet will be in Lafayette, Indiana. Discussion about why Michigan doesn't host the Central Meet more often. Tim also reported that there is a new region – Pocono Mountains Region. Tim reported that *G&D* editor Kate Sullivan has resigned to pursue further education and is being replaced by longtime *Hemmings Motor News* writer Jim Donnelly. • **Sunshine Report by Marjorie Henige:** Death of Walt Arvoy prompted a discussion about whether to continue to send memorials or flowers to families of deceased members. Motion made by Dave Rickabus, seconded by Tim Mehl, to allow Marjorie to send a memorial contribution to the family of Walt Arvoy. [Secretary's note: Sunshine Committee has a budget every year to send flowers or memorials; it is their discretion as to how to use those funds, within the budgeted amount.] • **Historian Report by Bruce Granger.** Bruce reported that he has received photos from Walt Arvoy's collection. He has also received a number of *G&D* magazine spanning almost the entire history from several different contributors. **2018 Events Calendar** was noted and will be published once reviewed for accuracy. • **Tech Time:** No discussion. • **50-50 Raffle:** Leon Eisenman, who was welcomed to the meeting after being absent for several months, won the \$30 pot. Thanks to all who contribute! • **Badge Fines** were collected. • **Meeting was adjourned at 3:40 p.m.**
