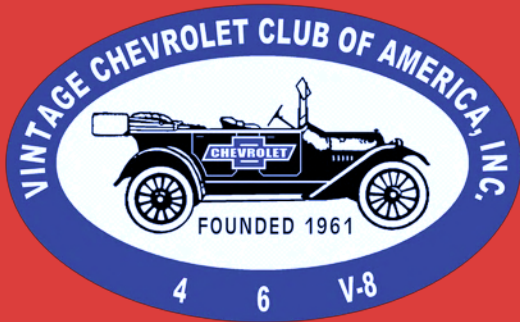

## Email Scams Alert!

**A couple of email scams have been identified using names of club members. Please note that the club will NEVER solicit funds or any other form of payment via email without a clear explanation in the Chevy Chatter newsletter as well.**

**If you ever receive suspicious email there are a few things you can do:**

**First, check the email from which it came. The sending email is usually shown in <> brackets. Make sure the email shown is familiar to you.**

**Second, contact the sender using a trusted email or phone number to verify the email.**

**And lastly, if the email is suspect, do not reply to it and do not click any links in the message.**
